



APPLICATION FOR CIVILIAN BASE ACCESS TO THE PATRICK AFB MANATEE COVE GOLF COURSE

READ THIS FIRST

Manatee Cove Golf Course (MCGC) is a Department of Defense (DoD) golf course that allows restricted access for civilian golfers. There are limitations on tee time privileges for civilians.

The method for granting limited (*golf course only*) base access to civilian golfers is to do a security background check and issue a (*golf course only*) badge. This simple basic background check can usually be completed within seven (7) working days following receipt of the application. You will be notified that your application has been sent to security and will be provided a phone number to contact them for clearance.

Once a favorable background check is completed and a badge has been issued, an interview with a Golf Course staff member is required. During this interview, the conditions and restrictions of base access are reviewed and the applicant is asked to sign a form indicating agreement to the terms and conditions of access.

When an applicant is approved, only the individual will be permitted access, as identified in the application, and must present his/her badge to the guard at the gate. If you plan to play with other civilians, each individual civilian must be cleared.

All personnel and their property are subject to search while gaining access to or on Patrick AFB. Seat belts must be worn at all times while on base. Talking on a cellular phone while operating a motor vehicle is prohibited.

The limited base access to the Golf Course is via the south gate only (from South Patrick Drive). After being cleared through the gate, turn left immediately after the gate onto Marina Road and continue to the golf course for use of the facility. When use of the facility is completed, you must use the same route to directly exit the base. Any deviation from this route will result in the loss of base entry privileges. Your personal data in this application will be used to complete a police background check to determine eligibility for access to the base. All personal data will be kept confidential and protected under the terms Privacy Act. The badge will be valid for one year from date of issue.
